Brooklands Treasurers Annual Report for 2024 AGM

This report relates to the financial year ended on 31st March 2024 and is best read in conjunction with the 5-year financial statement. (see pages 5 & 6 of this booklet)

The surplus for the total financial activity of all our groups increased substantially in the last year from £6,824 to £14,389. The main changes are:

- The day centre (including the cost of paid staff) improved by £4,809 to a surplus of just £430 this is the first time that the day centre has not had an operating deficit and is a real credit to Sandra's housekeeping skills!
- The lunch club operated for a full year for the first time since Covid, resulting in an improvement of £1,460.
- Pop-In improved by £831 due to increased Tai-Chi numbers.

Other groups generally operated at similar levels to previous years - which is not to understate the value of their activity. As Treasurer, I am most grateful to those Volunteers who manage the finances of individual groups for their accuracy and management of monies.

Premises letting income was £10,860 - down 12% from the previous year's high.

Donations were up 19% at £10,424 - a real tribute to the generosity of our townspeople and also to the high regard people have for the work of Brooklands.

Sandy and her helpers are due our grateful thanks that fundraising activity has raised around £5,000 again this year - often fun, but after much hard work.

All these positive movements resulted in a 22% increase in net activity income at £40,563. Set against this income are the central costs of operating our Centre, running our vehicles and office costs. Together these remained similar to the previous year at around £46,000.

This resulted in an operating loss of £5,044 - down from £13,000 the previous year. This shows the importance of the interest we obtain on our investments, which remains fixed at around £16,000 a year. After depreciation on the buildings and vehicles the final figure was a surplus of just £485 (prior year a deficit of £3,617).

The Centre has for many years held its long-term investments in a charitable fund which produces regular returns of around 4% per annum (the £16,000 mentioned above), but the value of our holding varies according to market fluctuations across the world. In some years there are losses in value (2022/23 loss was £22,045), but over time there has been a substantial benefit, and last year the value of these investments rose by £50,482).

Turning to the centre's balance sheet, the value of investments is now £600,000 and the book value of buildings and vehicles is £713,000. This is only a book value - the real cost of replacing these assets would be about four times this figure.

Our "current" assets – mainly bank balances – were £24,000, giving an overall level of assets at £1.337million. Over time, the Centre has received some significant grants towards buildings and vehicles and the annually reducing value of these is now £544,000 – funds potentially refundable to donors if we sold the assets. This leaves the Centre with £793,000 of unrestricted funds, 75% of which is now backed by the £600,000 of investments.

In financial terms this has been a positive year and the centre remains in a very sound financial position.

Brooklands Transport Annual Report for 2024 AGM

1 - Vehicles

The Brooklands Centre owns and operates two wheelchair-accessible minibuses for the purpose of transporting members to and from Centre activities. Both buses are regularly maintained, taxed and insured for this purpose.

The larger of our buses, popularly known as "Daisy", is a Citroën Relay van conversion purchased in 2014, and although now 10 years old, is generally still in good working order, with a low mileage of just over 30,000 miles. Daisy is capable of carrying 11 passengers plus the driver and escort. Generally Daisy carries one less seat so that a wheelchair passenger may also be carried, if required. The spare seat is stored in the outside shed extension. Wheelchair passengers can be transferred on and off the bus by means of a hydraulic electrically-powered folding tail lift, operated by a control panel inside the left-hand rear door of the bus. Both wheelchair and passenger are then safely secured using a set-up of clamps, straps and seat-belts. The lift is professionally serviced and tested approximately every six months. Access for other passengers is through the left-hand side door, with a manually-operated side-step and high-visibility yellow safety rails. Walking aids can be stowed in the rear of the bus or by the side step.

Our smaller minibus, commonly known as "Baby Bus", is a Citroën Despatch van conversion purchased in 2018, so is now 6 years old. Thanks to a year or more out for Covid, and slightly less usage than Daisy, Baby has only just crossed the 10,000 mile mark, and so is scarcely run in. The expensive problem with the "Ad-blu" emissions reduction system which occurred following Covid has thankfully not recurred. Baby is theoretically capable of carrying up to 6 passengers plus driver and escort. However, the centre front bench seat is impractical for anyone with less than full mobility or larger than small stature. In addition, the simultaneous use of both rear folding seats is not ideal, especially if walking aids are carried. So the practical limit on passengers carried is generally only 4. This can lead to multiple short runs having to be carried out compared to Daisy. Baby bus has a manually folding rear ramp and an electric winch

to allow wheelchair access. Straps and seatbelt arrangement ensures that wheelchair passengers are carried in safety.

Road tax is zero-rated for both vehicles as they are disability-enabled.

Motor insurance falls due each June, and incurs the greatest single transport expense for Brooklands, totalling around £2,000 in 2024.

2 - People

We currently have 13 minibus drivers on our books, of whom 8 are eligible to drive our larger bus, the remaining 5 being entitled to drive Baby bus only (This is thanks to the DVLA D2 category which permits most drivers to drive a minibus with up to 17 seats - this category is automatically revoked when a driver reaches the age of 70 unless they request it to be retained - this must be done every subsequent 3 years and requires a doctor's review)

In general we have enough drivers to cover our daily needs, though holidays, sickness etc sometimes cause us to struggle to meet the need.

Brooklands has long held a policy that minibus drivers should be accompanied by an escort, for reasons of safety and safeguarding. We have a variable number of escorts on our books, and frequently have shortages in this role. Brooklands groups tend to source their own escorts, though there is a certain amount of load-sharing between groups. We have a need for extra escorts to cover for absences

On behalf of the Brooklands Trustees, I would like to thank all of our wonderful drivers and escorts, who have freely given of their time during the last year, and made it possible for many of our members to attend Brooklands sessions, where this would not otherwise be possible. We could not do it without you. Sincere thanks.

3 - Usage

The minibuses are regularly used by the Day Clubs, Thursday Exercise Group, Friday Carers' and Saturday Lunch Club, carrying members from home to Brooklands and back again. A nominal charge is made for this service.

In addition, the Thursday afternoon walking group uses the minibuses to enable the group to travel further afield on their walks.

Groups such as the Gardening Group and the Thursday Exercise Group occasionally make use of one of the buses to go out on visits, for example to garden centres. These trips are only possible when the buses are available, and an additional charge is made.

Groups and organisations other than the Brooklands Centre are occasionally permitted to make use of our minibuses provided that their aims are charitable and similar to our own. Strict conditions are enforced regarding our buses' use, and we will always supply our own driver, though the group will supply the escort. The Castlemead Care Home in Newport Pagnell has used Daisy to take wheelchair passengers on shopping trips on a couple of occasions during the last year, and has made donations to Brooklands.

I have ordered two new noticeboards, one for use in the dining area and one over Sanda's desk. Hopefully, next year will be less expensive.

Everything we do is fun, but fund raising is getting harder and members are getting very fragile.

Brooklands Training Annual Report for 2024 AGM

In the past 12 months as well as filling in with odd jobs such as trips to the tidy tip and keeping the veranda and outside tidy, I have also taken on the role of Training Organiser.

It is important that the volunteers have training to enable them to assist our clients when the occasion occurs. With this in mind we have organised two defibrillator training courses which were run by Andy Graves and were attended by a total of 16 volunteers who learnt how to use the defibrillator in case of an emergency and also some aspects of CPR and mouth to mouth resuscitation.

We then had a fire training exercise which attracted 15 volunteers who attended and found out the procedures in case of fire, how to exit the building and where to meet to take the register so as to establish any missing clients or volunteers. Also, although we didn't have any fire or flames to deal with, Gareth had brought some fire extinguishers which we got to handle, so we had firsthand knowledge if we encounter some flames, but only if we feel capable, if not, leave it to the professionals.

Our next training course was 'First Aid', which we had opted for a course run by UK Training, a specialist company; this proved very successful as we all passed with flying colours, and although we haven't had to put any of the lessons into practice at Brooklands, we never know when our expertise is going to be called upon.

Hopefully, in the forthcoming year we hope to run further courses on Food Hygiene, Dementia, and probably another First Aid course.

Brooklands Day Clubs Annual Report for 2024 AGM

Monday Day Club - The Monday Day Club meets from 9.30am - 3.15pm. It's held in the main ground floor room and dining room. There are 22 members on the register with an average of 20 people attending the day club and 20 attending the exercise group. Transport with the use of both buses is provided to collect members who live within Newport Pagnell. There are 9 volunteers. We have some difficulties with volunteers who can do escort duties.

The purpose of the group is social interaction and a lunch club, plus the exercise group, with interaction between the exercise group and day club members. Activities undertaken include the exercise class, plus bingo, quizzes and a raffle for the day club members.

The best thing has been to see the exercise group and day club members interacting with each other, and seeing a team of volunteers working so well together as a team. The biggest challenge has been losing members to care or passing away, with 6 members passing away. The biggest challenge has been members becoming frailer mentally and physically. Welcoming new members can be difficult for some members, but 4 new members have joined.

Monday Exercise Group - The Monday Exercise group meets on a Monday from 10.00 - 12noon in half of the main hall. There are 32 members on the register with an average attendance of 17, some of whom stay for lunch. The session starts with coffee from 10.30 - 11am, followed by the Exercise Class from 11 - 11.45, led by Kamal Saggu of 1st Step Rehab Fitness & Support. Lunch is available from 12noon - 1pm. There are 2 volunteers.

The purpose of the group is to take part in a seated exercise class. The best thing about the group is regular attendance and the social aspect of the group. The biggest challenges for the group have been the heat, and also bank holidays as many of these fall on a Monday.

Tuesday Day Club - The Tuesday Day Club meets from 9.30am - 3.15pm. Some members start upstairs in the function room, although some start in the dining room downstairs. Then all use the main ground floor room and dining room. There are 30 members on the register, with an average attendance of 26 people, supported by 8 volunteers. Both buses are used to collect members who live within Newport Pagnell.

The purpose of the group is social and lunch club and social interaction. Activities undertaken include a raffle, quizzes and interactive games every Tuesday with occasional entertainment, e.g. singers. The best thing is welcoming new members and working alongside a fabulous volunteer team. Peter has attended every session! We have an average of 16/17 people on each walk, our highest number being 23, and our lowest number 11.

The group not only promotes exercise through a gentle walk, but is also a social occasion to chat and make friends, as well as an opportunity to explore the local area, looking at local history and culture. We have walked in Great Linford Manor Park, through Great Linford village, along different sections of the Railway Walk, along different sections of the Grand Union Canal, including the Art Trail on the canal; we have followed the line of the old Newport Pagnell canal and walked in Newport Pagnell in Bury Field, in the Poets Estate and in Green Park. Brooklands Carers' Group Annual Report for the 2024 AGM

The Carers' group at Brooklands has now been running for 26 years. The group meets every other Friday from 10am until 12noon in the main downstairs room.

There are currently 39 people on the register, with an average of 21/22 people attending each session, with up to 28 people on occasions. We have 12 couples, 2 mothers and daughters, and 11 people who attend on their own as their spouse is either in a care home or has passed away. We have lost 4 members this year, 1 person moving to a care

home and 3 members passing away. We have gained 12 new regular members, as well as having others attend during the year for just an occasional session. Transport is provided for some members who live in Newport Pagnell using the mini-bus, although we have members from all over Milton Keynes.

The group is supported by seven volunteers, who are very involved in running of the group: Helen Taylor, Rita Galloway, Barbara O'Reilly, Cherie Read, Linda Glidewell, Imti Farookhi and since August, Owusu Twumasi who now drives the little mini-bus for us. David Hulance was a regular volunteer, but now provides back up cover as a driver if needed. We were sorry to lose Sue Sweet, one of our volunteers who had been helping us for two years. She passed away suddenly and unexpectedly aged 74 at the end of July.

The purpose of the group is to support carers of people with all forms of dementia. In the first hour, refreshments (prepared in the kitchen) are provided, whilst members chat and interact with each other, supported by volunteers and the Admiral Nurses. Some members have been attending the group for many years and can offer support to newer members. A raffle also takes place at this time.

The second hour includes an activity: Musical entertainment (The Rolling Home Band, MK Rock 'n' Roll Choir and Norman's Crusaders, all of whom have performed for us twice this year), seated exercises to music with Kamal, Love to Move sessions, information sessions, Reminiscences sessions, animal sessions, games sessions, fun activities and regular arts and craft sessions provided by Sara and Judy from MK Community Learning. Throughout the morning one of the Admiral Nurses is on hand to offer one-to-one support to the carers, to listen, counsel, and provide advice, information and support. Either Sue Webb, Lead Admiral Nurse, or Lorretta Peck attend each session.

There have been no major changes in the group in the past year. It continues to be a popular group with many members saying how much they look forward to the sessions. The group continues to thrive and provide invaluable support and friendship to carers of people with dementia and their loved one.
